**1. What is the research study about?**

You are invited to take part in this research study. The research study aims to examine the workplace relationship issues commonly arising between Higher Degree Research (HDR) candidates (known as graduate researchers at some universities) and their supervisors (known as advisors at some universities), and how these issues are managed within Australian universities. Such issues include mismatched expectations, communication problems, bullying, supervisor and candidate performance, conflicts of interest, inappropriate relationships and attachments and sexual harassment and sexual assault. The results of this research study will help to address knowledge gaps, enhance understanding of the HDR experience, and provide the basis for training in more effective responses.

**2. Who is conducting this research?**

The study is being led by the Australian Human Rights Institute and the Gendered Violence Research Network at UNSW Sydney. The research is being carried out by the following researchers:

- Dr Allison Henry – Research Fellow, Australian Human Rights Institute, UNSW Sydney (CI, Project Manager, Lead Researcher).

**3. Inclusion/Exclusion Criteria**

- currently enrolled as a Higher Degree Research (HDR) candidate (ie undertaking Masters by research, PhD or Professional Doctorate) at one of the 10 participating universities

**4. Do I have to take part in this research study?**

Participation in this research study is voluntary. If you do not want to take part in the interview component of the study, you do not have to.

Participation in this research study is separate from participation in your HDR program and choosing to/not to participate will not have any impact on your program of study.

If you decide to take part and later change your mind, you are free to withdraw from the study at any stage.

If you decide you want to take part in the interview component of the research study, you will be asked to:

- Read the information carefully (ask questions if necessary);
- Sign and return the consent form if you decide to participate in the study;
- Take a copy of this form with you to keep.

**5. What does participation in this research require, and are there any risks involved?**

If you agree to participate you will be asked to complete the following research procedures.

**Screening:** Participants in interviews will have first completed the online survey for this research project and then indicated their willingness to be interviewed. The initial questions in the online survey, following consent, will serve as a screening questionnaire and ensure that participants meet the inclusion criteria for both the online survey and interviews.

**Interview:** A semi-structured online video interview, when you will be asked questions about your HDR candidate experience, explore views and perceptions of the HDR candidate-supervisor relationship, and how problems in the relationship are managed. The interview will take place will be conducted via online platforms such as Teams or Zoom and will take 30-45mins.

With your permission the research team would like to audio record the interview so that the data collected from you can be accurately documented. The audio recording will be transcribed and coded. Please see information below about how the audio recording and transcription documents will be accessed and stored.

Your consent to record the interview will be sought at the beginning of the interview. If you do not wish to be recorded but you would like to participate you can advise the research team and written notes will be taken instead.

You will receive an initial reminder and one follow up reminder.

**Additional Costs and Reimbursement:** There are no costs associated with participating in this research project, nor will you be paid.

**Psychological Distress:** You may feel that some of the questions we ask are stressful or upsetting. If you do not wish to answer a question, you may skip it and go to the next question, or you may stop immediately. If you become upset or distressed as a result of your participation in the interview, the research team will be able to arrange for counselling or other appropriate support. Alternatively, a number of free contactable support services are included at section 10. Any counselling or support will be provided by qualified staff who are not members of the research team. This counselling will be provided free of charge.

**6. What will happen to information about me?**

By signing the consent form, you consent to the research team collecting and using information about you for the research study.

The research team will store the data collected from you for this research project for a minimum of 7 years after the completion of the research.

The information about you will be stored in a re-identifiable format where any identifiers such as your name and university will be replaced with a unique code.

You will be asked to provide your consent for the research team to share or use the information collected from you in future research that will be an extension of, or closely related to, the original project; or is in the same general area of research.

Your information will only be shared in a format that will not identify you.

- Information collected from you in an electronic format will be stored on a UNSW password protected OneDrive only accessible to the approved research investigators.
- Audio or video recordings will be stored on a UNSW password protected OneDrive only accessible to the approved research investigators and will be made available to a professional transcription service. Recordings will only be made available after a confidentiality agreement has been signed.

The information you provide is personal information for the purposes of the Privacy and Personal Information Protection Act 1998 (NSW). You have the right of access to personal information held about you by the University, the right to request correction and amendment of it, and the right to make a complaint about a breach of the Information Protection Principles as contained in the PPIP Act. The research team intend to publish and report the results of the research. All Information will be published in a way that will not identify you.
